COMPLETE THIS SECTION ONLY IF THE SPECIALTY PLATE IS TO BE PERSONALIZED

APPLICATION FEE: \$40.00 PER YEAR
(This fee is in addition to the specialty plate fee.)

- Selections must be shown exactly as you wish them to appear on the license plate.
- If approved, the personalized license plate will be manufactured and mailed to your County Tax Assessor-Collector.
- **A license number that has already been issued or is deemed to be inappropriate will not be approved.**
- Each square of the selection block may be used to represent one letter or number character, punctuation symbol or space.
- **No more than five (5) characters, spaces, punctuation symbols or silhouette of Texas.** Punctuation symbols which may be used are periods, dashes or blank spaces. **Use an asterisk (*) to indicate the Texas silhouette.**
- The International Symbol of Access (Disabled Person Emblem) requires two selection characters. If you are applying for a personalized plate, the selection may consist of no more than three characters, spaces or punctuation symbols in addition to the ISA. **Use the percent sign (%) to indicate the International Symbol of Access. Please include a completed Form VTR-214.**

THE SPECIALTY PLATE FEE MUST BE PAID ANNUALLY IN ADDITION TO VEHICLE REGISTRATION FEES.

Questions regarding your application should be directed to the Special Plates Branch at 512/374-5010.

TO OBTAIN THE SPECIALTY LICENSE PLATE, you may be required to surrender your current license plate and validation sticker to the County Tax Assessor-Collector. The regular registration fee and other applicable fees must be paid to the County Tax Assessor-Collector for the period for which the specialty license plate is valid. If your trailer is currently registered when the specialty license plate is issued, the registration expiration date may need to be adjusted to correspond with the expiration of the specialty license plate.

If necessary, additional fees will be collected to make this adjustment.

PLEASE CONTACT YOUR LOCAL COUNTY TAX ASSESSOR-COLLECTOR'S OFFICE IN TWO WEEKS TO VERIFY YOUR PLATE IS READY FOR DELIVERY.
