



Background

- Processing & Handling (P&H) fee
 - Replaces the \$1 Automation Fee and for renewals the \$1 Mail-In Fee

 - Authorized by statute and administrative rule:
 - [§217.183](#) Fee Amount (P&H)
 - [§217.184](#) Exclusions (P&H)

P&H Fee Collection

- All dealers will collect the P&H Fee on transactions with registration fees
- Dealer title transfers:
 - RTS Transaction date Jan. 1, 2017 and later
 - webDEALER Creation date of Jan. 1, 2017 and later

P&H Exclusions

- P&H fee is not collected for the following transactions (no registration fees):
 - Vehicle registered as Exempt
 - Reduced-Fee or No-Fee Military license plates
 - Title Only transactions
 - Off-Hwy vehicles

Dealer Deputy

Vehicle Dealers may act as a dealer deputy to provide titling and registration services.

[§217.168](#) Deputy Fee Amounts

- Licensed Dealer or Commercial Fleet Buyer
- Deputized by County Tax Assessor-Collector with approval from county commissioners court
 - Dealer issues plates and stickers
 - Dealer uses webDEALER
 - Bond payable to the county assessor-collector must be posted

Dealer Deputy Compensation

- Dealer Deputy: webDEALER dealership that issues plates and stickers
- Begins with dealer title transfers: Jan. 1, 2017 and later
- Compensation for Dealer Deputies Only
 - Up to \$10 Title Convenience Fee ([§217.168](#))
 - \$1 from P&H fee ([§217.168](#), Deputy Fee Amounts)
