

**THE AUTO BURGLARY AND THEFT PREVENTION AUTHORITY (ABTPA)  
STEVE DAVENPORT AWARD & STAR AWARD  
SELECTION CRITERIA**

**ELIGIBILITY:** Any regular full time employee of the ABTPA Grant Programs. One investigator and one staff shall be honored each year. Task Force Directors are not eligible.

**NOMINATION REQUIREMENTS:** Nominees are to be individuals who have demonstrated outstanding service and dedication in fulfilling the Mission and Vision of ABTPA. Any ABTPA employee may submit nominations.

**NOMINATION PROCEDURES:** Nominations must be submitted in essay form (one page/500 words or less) to the ABTPA office in Austin by the date required on memo sent to Task Forces. The nominations shall include the following:

- A description of the individual's contributions.
- A description of the significance of the contributions and how the contributions are clearly beyond the contributions of other individuals.
- Specific accomplishments which make the nominee truly outstanding and reflect the individual's dedication to ABTPA's Mission and Vision.

**SELECTION PROCEDURE:** An Awards Review Committee consisting of the Grantee Advisory Committee will submit six award nominees from the list of candidates and the Selection Committee who will make the final selection of those to be honored.

**SELECTION CRITERIA:**

1. Contributions clearly beyond those of other individuals in supporting the Mission and Vision of ABTPA.
2. Contributions exhibit outstanding service and dedication.
3. Candidate has exhibited outstanding leadership.
4. Candidate has provided outstanding assistance to auto theft reduction in their program area.
5. Candidate has made significant accomplishments in developing growth of self or others.
6. Contributions enhance the working environment.
7. Contributions enhance image of ABTPA and/or the community.
8. Contributions of significant effectiveness and efficiency to the task force and auto theft vehicles administration.

**SELECTION COMMITTEE:** Selection Committee will consist of the ABTPA Grantee Advisory Committee.
